Fresh is Best

If you agree with the quoted price, we will provide you with an estimated schedule date, the grass will be cut & you'll get it via the method of your choice (delivery, installation, or pick up.



Move Over, Florida!

Florida law requires you to Move Over a lane - when you safely do so - for stopped law enforcement, emergency, sanitation, and utility service vehicles, tow trucks or wreckers, and maintenance or construction vehicles with displayed warning lights without advanced signs or channelizing devices.


• If you cannot move over - or when on a two-lane road slow to a speed that is 20 mph less than the posted speed limit.

• Slow down to 5 mph when the posted speed limit is 20

mph or less

When you fail to Move Over, you put yourself and others at risk; you could crash into a vehicle or worker.

Violating the Move Over law will result in a fine, fees, and points on your driving record. For more information, see section 316.126, FS.
